Henry Ford Jackson Hospital (HFJH) Al Glick Scholarship FAQs

Q When can I apply for the HFJH Al Glick Scholarship?

A Students may apply between: Monday November 3rd, 2025 – Friday February 13th, 2026

Q What are the eligible programs for 2026?

A Registered Nurse, Surgical Technologist, Medical Assistant, Respiratory Therapist, Athletic Trainer, or Social Worker.

Q Who qualifies for the HFJH Al Glick Scholarship?

A To be eligible, the applicant must be a current resident of Jackson County who meets the following criteria:

Currently enrolled in a college or university pursuing a relevant degree for one of the applicable programs/positions; or

A 2026 graduating high school senior; or

Jackson County Early College student completing their 13th year during the time of application submission; or

An adult learner/returning student with a high school diploma or GED.

Q Can I apply if I am a current HFJH employee?

A Yes, HFJH employees who wish to apply for this award must be a Jackson County resident and cannot currently be in any level of corrective action. Additionally, the employee's leader will be contacted for an internal reference.

Q Do I have to currently be attending or plan to attend a specific college or university?

A No, the scholarship may be applied to the college or university of the recipient's choice.

Henry Ford Jackson Hospital (HFJH) Al Glick Scholarship FAQs

Q What does the HFJH Al Glick Scholarship cover?

A The scholarship covers the recipient's last dollar tuition and tuition related fees each semester. The scholarship also provides recipients a \$500 bookstore credit each semester they are in attendance, to be used toward required books and course materials at their college or universities bookstore.

Q What is a last dollar scholarship?

A Last dollar refers to the manner in which the scholarship is applied to the recipient's college or university account. If the student has any other available scholarships or grants, these must be applied to their account first. The HFJH Al Glick Scholarship will then cover remaining tuition and tuition related fees. This is reassessed each semester and all tuition payments are paid directly to the recipient's college or university after they have invoiced HFJH.

Q Does the scholarship cover room and board, meal plans, or other non-tuition related fees?

A No, the scholarship covers only last dollar tuition and tuition related fees.

Q If awarded the HFJH Al Glick Scholarship, what is the requirement or commitment of the scholarship recipient?

A Scholarship recipients are required to sign the HFJH Al Glick Scholarship Agreement. Within this agreement, the recipient agrees to maintain a minimum 2.5 GPA., provide HFJH with a copy of their unofficial transcript each semester, complete their certificate or degree within an appropriate timeframe depending on program requirements, and commit to two (2) years of employment with Henry Ford Jackson Hospital post certificate or program completion.
